Informal Decision Making

(No hearing is required.)

- > Filings, Applications & Petitions Received.
- > SAPA Process (State Administrative Procedures Act)
 - -Notice published in the State Register
 - -Public comments may be received
 - -Delay action by 45 days after publication
- ➤ Assignments made to an Office(s) for review and processing.
 - -Staff will confer with an applicant/petitioner
 - -Additional information may be requested
 - -May seek modifications and changes
 - -Staff will review comments received
 - -Session items are reported to the Commission
- The Commission takes action and decides.
 - -At an meeting open to the public
 - -On a formal record
 - -Session Items are discussed among the Commissioners (some "consent" items are not discussed)
 - -Votes are taken to adopt the Staff recommendations

Formal Decision Making

(A Hearing is Required.)

A hearing may be required by law

Statutory Requirements: -Rate Cases

-New Transmission Lines, Natural Gas Pipelines & Electric Generation Facilities

The Commission may decide to hold a hearing

Commission Discretion: - Generic Policy Case

(Current Example: Manufactured Gas Sites Clean-Up)

An Administrative Law Judge is assigned to the case

- -Establish a Schedule
- -Conduct a Public Statement Hearing

The public is invited to make statements.

-Conduct an Evidentiary Hearing

Testimony is received from expert witnesses provided by the utility company, our "trial" staff and any outside parties/intervenors.

-The Judge Prepares a Recommended Decision

Lawyers provide briefs addressing facts and containing arguments,

Formal Decision Making – Continued (A Hearing is Required.)

- Advisory Staff evaluates issues and offers advice
 - Advisory staff meets with the Chairman and Commissioners.
 - Advisory staff provides opinions and recommendations
- Commission renders decision from a formal record
 - -At an open meeting
 - -On a formal record
 - -Session items are discussed among the Commissioners
 - -Votes are taken to adopt the Staff recommendations

Formal Decision Making Without a Trial

Alternative Dispute Resolution (ADR) also known as Stakeholder Collaboratives

- ➤ Problem Solving Process Diplomacy and Open Discussion
- Consensus Building Process Remove Barriers to Good Communications
- Convene Meetings and Invite Stakeholders
- > Provide a Facilitator Staff Member Trained in ADR
- ➤ Work Together on a Written Agreement Joint Proposal
- Submit Agreement to the Commission for Adoption/Approval
