






End Use Electricity Efficiency


1. The Energy Mix in Jordan (2007 – 2020)

2007




Domestic Resources 4%, Imported 96%

2015




Domestic Resources 25%, Imported 75%


2020

[3. Government Actions]

So what has the government done to date to achieve this goal?

- **The recently passed Law No. (13)/2012 For RE & EE.**
- **Establishment of Renewable Energy & Energy Efficiency Fund (JREEEF) which will play a key role in channeling funds to selected projects.**
- **On 16th April 2012 EE Bylaw has been approved from the Minister & sent to the PM for Final Approval.**
- **The bylaw of Energy Efficiency, will set out clear targets across sectors, programs, and responsibilities.**

- **EE Bylaw Main Objectives Are To:-**
 - **Performing Energy Audit (E.A) for all entities (Govt. & Private).**
 - **Compulsory E.A for entities consumes more than 50TOE/year.**
 - **MEMR's responsibility to prepare the Jordan's NEEAP.**
 - **Promotion projects of E.E.**
 - **Certification of ESCOs through the EE bylaw & its associated instructions.**
 - **Adopt Energy Label (E.L) in cooperation with concerned entities.**
 - **Tax exceptions for E.E equipment & devices.**
 - **All new households, commercial buildings are obliged to prove the installation of SWHs.**
 - **Annual prize for EE based on a competition basis.**

[4. Running Activities]

a. Presently:-

Promotion Mechanism concerning CFLs & SWHs:-

- ✓ Promotion PP Project concerning replacement of CFLs at the Govt. Entities.
- ✓ Enforcement Mechanism for the SWHs through the EE bylaw.
- ✓ **Certification of ESCOs through the EE bylaw & its associated instructions.**

b. Short Term:-

Holding the National Energy Efficiency Action Plan(NEEAP) WS for final comments.
