
Status and Future of ERE's Licensing and Concession-granting authorities



Licensing

Licenses shall be granted by the ERE pursuant to procedures that assure equal, non-discriminatory treatment and transparency of the license process. Such procedures shall specify the information that must be filed with request for each type of license application.

Licensing Conditions

ERE shall determine the conditions for every license taking into consideration:

- the term requested for the validity of the license;
- the locations and territories on which the licensed electric power activities will be performed;
- operating safety and reliability of facilities, equipment or the network;
- requirements for the nature of primary energy sources;



Licensing Conditions (Cont.)

- requirements connected with national security, citizens' life, property and health and public order;
- financial requirements;
- environmental protection;
- promotion of energy efficiency in the electric power sector;
- public service obligations as provided for by this law;



Licensing Conditions (Cont.)

- promotion of a competitive electric power market and leastcost principles in electric power supply; and
- the effect upon security and reliability of electric power supply within the territory of the Republic of Albania.

Concession authority

 Actually, the concession practices are followed by the Ministry responsible for Energy.

Concession procedures

- We follow the same procedures based on our Rules and Practices of licensing as for concession licensees and others.
- We grant them the same license type based on their type of activity

Future

- The Law on Concessions is in the process of being developed, and there is a working group dedicated to that.
- Essential changes should be made to the procedures for concession granting.

The actions taken by ERE so that a company can comply with its rules

Transparency in drafting and approving all the secondary legislation, granting licenses, transferring licenses, etc. by publishing the data before approval by the Board of Commissioners so that all stakeholders will be able to state their opinion and also become familiar with what the Regulator is doing.

After the decision is reached, it is published in the media, in the official gazette and on ERE's website.
