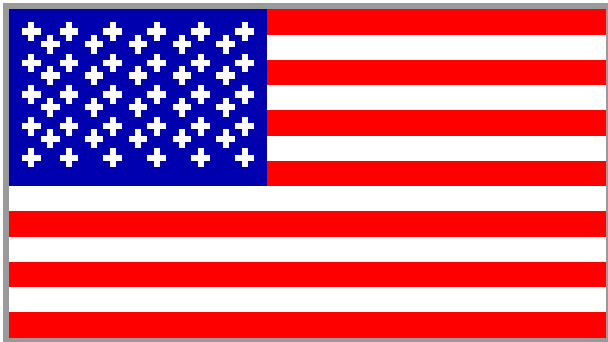
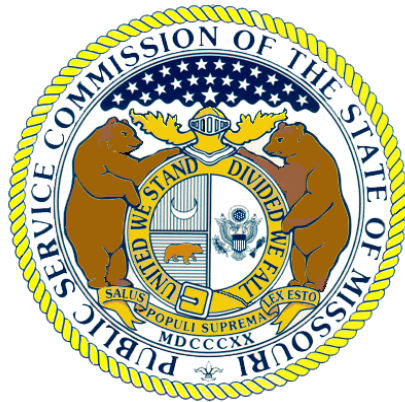

Social Policies and Tariffs

Social Policies and Tariffs

Tariffs provide the basis of services and corresponding charges for a utility. They basically describe all the charges, terms of service, and obligations of the utility and the customer. They are derived through the following three items:

- Missouri Statutes
- Commission Rules
- Commission Case Decisions

Social Policies and Tariffs

1) Statutes:

Statutes are laws that have been enacted by the legislature and signed by the Governor. They are enacted as public policy. They give the Commission the Legal Authority to regulate the investor-owned utilities within the State.

Statutes represent the general basis and guidance of utility regulation in the State of Missouri.

Social Policies and Tariffs

Many statutes are general in nature but some provide detailed specifications regarding the application of certain utility costs and services. State Statutes 386 and 393 apply to the Public Service Commission's authority and purpose.

Social Policies and Tariffs

2) Commission Rules:

The Commission's rules provide the tariffs with detailed language, definitions, and applications. They are utility type specific (natural gas, electric, telecommunications, water, sewer, manufactured housing, etc...). These rules prescribe standards, practices and requirements that a utility must abide by.

Social Policies and Tariffs

3) Commission Case Decisions:

Utility rates and specialty tariffs are derived from Commission decisions in cases. These are often specific to a particular utility company. These decisions establish customer classes, corresponding rates for those customer classes, and define the terms and conditions of utility service.

Social Policies and Tariffs

Social policies that are implemented through any of these mechanisms will typically be integrated into the tariff since it often serves as a “stand alone” document.

Social Policies and Tariffs

Some of the social policies that often appear in tariffs include low-income programs, programs for energy efficiency, and special terms for disconnection of customers who have not paid their bills.

Social Policies and Tariffs

A Sample Breakdown of an Electric Tariff:

Description of Territory

This portion of the tariff incorporates the description of the service territory the electric utility is authorized to provide electric services.

This can include copies of maps and legal descriptions of the area.

Social Policies and Tariffs

Residential Service

Qualifications for a residential customer is a single dwelling or to multi-family-dwellings within a single building.

General Service

General Service would include the following customers:

Commercial, Small Heating Service, General Power Service, Large Power Service, and Special Transmission Service Contracts

Social Policies and Tariffs

Special Services

Special Service would include the following customers:

Municipal Street Lighting, Private Lighting Service, and Special Lighting Service

Social Policies and Tariffs

Riders

Riders often represent social policies or special contracts and may be used for items such as promotional practices, interruptible service, average payment plans and low-income programs. These tariffs usually target certain retail customers and assist these customers in ways of enabling them to pay their utility bills.

Social Policies and Tariffs

Rules and Regulations

This portion of the tariff incorporates the statutes and rules that are prescribed by the Commission. These tariff sheets govern the standards, practices and requirements that an electric utility must abide by.

Instructions for how to access the Public Service Commission's website to review currently effective tariffs (Empire Company tariff is used as example):
