## GAS-1 (EL-2) - Resolution Honoring David Hadley Commissioner Indiana Utility Regulatory Commission

**WHEREAS**, David W. Hadley served as Commissioner of the Indiana Utility Regulatory Commission (IURC) since 2000. He was appointed to the IURC in February 2000 by the Governor O'Bannon. He was reappointed by Governor O'Bannon in 2002 and reappointed by Governor Daniels in 2006; *and* 

**WHEREAS,** Prior to his appointment, Commissioner Hadley served as an executive officer for the Indiana AFL-CIO, business development specialist with the Indiana Department of Workforce Development, a union coal miner where he held numerous leadership positions and served as a legislative affairs representative for the United Mine Workers of America, and as a high school social studies teacher; *and* 

WHEREAS, Commissioner Hadley served as Chairman of National Association of Regulatory Utility Commissioner's ("NARUC") Clean-Coal Subcommittee. He also served as a member of the NARUC Committee on Gas and the NARUC Committee on International Relations. In his work with the Committee on International Relations, Commissioner Hadley traveled to assist Commissions in Eastern Europe and Africa; and

**WHEREAS**, Commissioner Hadley has served on the Board of Directors of the Organization of Midwest ISO States and the Organization of PJM States; *and* 

**WHEREAS**, Commissioner Hadley has served as Vice Chairman of the Gas Technology Institute's Public Interest Advisory Committee; *and* 

**WHEREAS,** Commissioner Hadley and the Clean-Coal Subcommittee have been at the forefront of this nation's efforts to foster development of this abundant natural resource. In addition to providing economic benefits to the nation, clean-coal holds the promise of ameliorating adverse environmental consequences of coal, reducing our nation's dependence on foreign energy supplies, and enhancing economic development in coal producing regions; *and* 

**WHEREAS**, Commissioner Hadley, in furtherance of his duties for the IURC, has assiduously attempted to balance the interests of customers, utilities, and investors while advancing good public policy; *and* 

**WHERAS,** Commission Hadley has been a leading advocate of development of programs that provide benefits to all customers such as demand-side management, cost-effective development of resources, and, especially, programs that provide assistance to the most vulnerable low-income consumers; *now therefore be it*

extends its sincere appreciation to Commissioner David W.
