# Record Attendance and Policy Talks Highlight NARUC Winter Meeting

## Policymakers Addressed Members; Key Resolutions Passed

WASHINGTON—The National Association of Regulatory Utility Commissioners concluded its Winter Committee Meetings with record attendance of more than 1,600 registrants. NARUC President Robert F. Powelson of Pennsylvania led the four-day conference, covering utility issues in energy, telecommunications, water and consumer affairs.

Notable panels included a kickoff general session on February 13, featuring Greg Walden (R-Ore.), chair of the House Energy and Commerce Committee, who rolled out his agenda for the coming year. Also, Federal Energy Regulatory Commission Acting Chair Cheryl LaFleur engaged in a Q&A session with President Powelson on February 14, preceded by a talk from Bill Shuster (R-Pa.), chairman of the House Transportation and Infrastructure Committee, who outlined priorities for addressing infrastructure issues and transportation matters.

President Powelson's theme for the year, *Infrastructure, Innovation, and Investment*, was reflected in the discussion topics of many sessions. In particular, the Presidential Task Force on Innovation and the Presidential Task Force on Veterans' Workforce committees were two popular panels, with standing-room-only attendance.

The effect of the new Presidential Administration on energy and telecommunications policies attracted much attention to this year's meeting. Relevant issues concerning resiliency, innovation and cybersecurity were other subjects covered during the meeting.

"The influence and credibility of NARUC was quite evident during the meetings," said Powelson. "We were able to attract political leaders and national experts to our panels and provide the type of meaningful information that our state regulators and stakeholders expect."

The meeting concluded with two general session panels. The first, moderated by Commissioner Judy Jagdmann of Virginia, examined the U.S. Department of Defense's increased focus on ensuring that resiliency measures are in place to protect the nation's power grid. Representatives from the Air Force, Army and Navy participated in the discussion. The final panel, moderated by NARUC First Vice President John Betkoski of Connecticut, provided insights for regulators on consumer utility scams. Utility, commission and consumer advocacy perspectives were shared.
