

*ERE-2 Resolution Honoring Washington Commissioner Pat Oshie*

**WHEREAS**, Commissioner Patrick J. Oshie was appointed to the Washington Utilities and Transportation Commission by Governor Gary Locke in 2001 and unanimously confirmed by the Washington State Senate; and

**WHEREAS**, Commissioner Oshie was reappointed by Governor Christine Gregoire in 2006, and again unanimously confirmed by the Senate; and

**WHEREAS**, Commissioner Oshie, having earned his law degree from the University of Washington in 1980, had an impressive legal career including practicing environmental and Indian law as a partner in a private law firm; serving as an assistant city attorney for the city of Seattle; serving as an Assistant Attorney General in the Utah Attorney General's Office; and serving as an adjunct professor of law at the University of Utah's College of Law; and

**WHEREAS**, As a member of NARUC, Commissioner Oshie served in many leadership positions including serving as Vice-Chair and Chair of the Energy Resources and the Environment Committee; as a member of the NARUC Board of Directors; as a member of the Consumer Affairs Committee; as a member of the Utility Marketplace Access Subcommittee; and as a member of the NARUC-Federal Energy Regulatory Commission (FERC) Demand Response Collaborative, which is a vehicle for State and federal regulators to discuss issues and make recommendations for State and federal policies to support demand response; and

**WHEREAS**, Commissioner Oshie is a recognized leader in the energy sector, earning a national reputation that caused him to be a highly sought after expert, having served as Co-Chair of the State Energy Efficiency Action Network, Measurement, Verification Work Group; on the Advisory Council to the Electric Power Research Institute's Board of Directors; on the Gas Technology Institute's Public Interest Advisory Council; on the National Council on Electricity Policy; on the Advisory committee for the Institute of Electric Efficiency; and on the National Action Plan for Energy Efficiency Leadership Group; and

**WHEREAS**, Commissioner Oshie served as an informal mentor to new commissioners, encouraging their learning and facilitating their active involvement and participation on the Energy Resources and the Environment Committee; and

**WHEREAS**, In addition to his in-depth knowledge of energy and other utility matters, Commissioner Oshie always had good tips for restaurants, knowledge of coffee baristas, strategies for buying and selling goods on E-Bay, and a seemingly infinite knowledge of other, mostly useless, information; and

**WHEREAS**, Commissioner Oshie played a mean rhythm guitar in the Washington Commission's house rock-and-roll band; and

**WHEREAS**, NARUC misses Commissioner Oshie's dedication, generosity, energy, intellect, and leadership in the NARUC ranks (not to mention his good humor); now, therefore be it

**RESOLVED**, That the Board of Directors of the National Association of Regulatory Utility Commissioners, convened at its 2013 Summer Meetings in Denver, Colorado, extend their
