

#### **Meetings**

A lot changed over a short amount of time! The Winter Policy Summit was held just a couple weeks before the pandemic hit. Attendance at the Summit was 1,555. This included 150 commissioners, 256 staff, 969 Stakeholders, 117 consumer representatives, and 20 members of the media. Planning for Western Rate School, the Summer Policy Summit, and the regional meetings were underway when the pandemic hit. So decisions had to be made to cancel or re-engineer these events to go online.

Western Rate School was cancelled and students were given the option of a refund or a deferral to a future Rate School. Luckily, roughly 25 percent chose the deferral and were given registration priority for the Eastern Rate School.

MACRUC and NARUC chose to deliver their meetings online. The decision made was based on the essential and relevant information needed for members and stakeholders. In less than eight weeks, these meetings were organized and actualized. With 450 registrants for MACRUC and 950 for NARUC, both meetings received high marks on the attendee evaluations. The breakdown of the **Summer Policy Summit** had 142 commissioners, 334 staff, 328 stakeholders, 65 consumer advocates, and 38 members of the media. Interestingly, staff and media participation increased, whereas commissioner levels remained close to normal and the stakeholder category had a large drop.

The Eastern Rate School re-engineered to go online with a dedicated and outstanding faculty willing to tackle technology challenges while maintaining the essential 'team functionality.' Deferred Rate School students were given first option to register. Then the list was opened to the rest of the Western Rate School registrants who cancelled and then to anyone. Registration quickly reached the 95 student cap and a waiting list of dozens more was created. Due to the online nature of Rate School, we also recruited 10 mentees to deepen the coaching and teaching team for future meetings. Preparation for Rate School included recording 12 of the 17 sessions, creating ZOOM team accounts, as well as a web-based resource page.

The NARUC Annual Meeting and Education Conference will also be held online and includes four general sessions, 12 concurrent sessions, a 'hot topics' session; meetings of committees, staff subcommittees, six task force/subcommittees, regionals, board of directors meeting; and more than 100 one-on-one ZOOM meetings with commissioners.

Sponsorship

Sponsors to all the NARUC meetings have been very supportive. A new sponsorship program was developed based on acknowledgments conducive to an online platform. More than \$185,000 has been committed between the Summer Policy Summit and the Annual Meeting and Education Conference.

Many NARUC team members 'upskilled' on technology to help produce outstanding meetings while reducing the need to hire outside experts. It has been a true pleasure working with members and NARUC staff during these trying times. The positivity and willingness is overwhelming. We are all looking forward to the return of in-person meetings.

#### Policy & Advocacy

#### **Energy Policy**

Just as the coronavirus has had a great impact on individual commissions, the same has been true for NARUC and the work of the Policy Department. Starting in mid-March, we responded to the pandemic by trying to keep members informed and up-to-date with industry and federal partners. NARUC hosted briefings and webinars and provided resources.

The Federal Energy Regulatory Commission (FERC) and the Pipeline and Hazardous Materials Safety Administration (PHMSA) briefed us on their responses to the pandemic. Electricity, natural gas, and water sector representatives explained the impact on their sectors and how they were trying to meet the needs of their customers under very challenging circumstances. We also heard from Wall Street about the financial impacts of the virus on the markets and utilities. These briefings led to collaborations with our federal and industry partners.

In addition to work on pandemic issues, our advocacy at the federal agencies, the federal courts, and Congress on behalf of the states has continued. Notable highlights follow.

#### **Key Initiatives**

Net Metering/State Jurisdiction over Rooftop Solar

Participation of Energy Storage Resources and Distributed Energy Resource Aggregators in Wholesale Markets

**PURPA Reform** 

At its July 2020 Commission meeting, FERC denied the New England Ratepayers Association's April 2020 petition challenging jurisdiction and pricing on procedural grounds. Two FERC commissioners' concurring statements emphasized that the decision was not based on the merits of the legal and policy arguments, leaving open a possibility that FERC could revisit the issues raised in the petition under a different procedural mechanism, such as a rulemaking.

For years, FERC has worked on new rules for wholesale markets to lower the barriers of entry for energy storage resources and distributed energy resource (DER) aggregators. In September 2020, FERC issued the new rule regarding DER aggregators participating in the wholesale markets and included a slightly modified version of the challenged language. NARUC will now seek to protect state jurisdiction in the implementation phases of the two rules.

In July 2020, FERC issued a final rule to modernize its Public Utility Regulatory Policies Act of 1978 (PURPA) regulations. This reform process began in 2016 and NARUC has advocated for certain changes for several years. FERC adopted most of the reforms for which NARUC advocated in the final rule, which will mean greater flexibility to the states in implementing the regulations.

#### Telecommunications, Water, and Nuclear Waste

#### Broadband

Because of the pandemic, numerous bills were introduced to provide incentives to promote broadband infrastructure. President Brandon Presley focused on blocking legislation to remove the designation procedure from the FCC's proposed Rural Digital Opportunity (RDOF) auction, which began in October, and he also sought changes to the auction process.

#### Lifeline & Inmate Calling

In June, we successfully promoted the federal "Lifeline" program and highlighted the program's increased importance in the wake of the pandemic. In September, NARUC led another successful Lifeline Awareness Week. We also joined the FCC in a joint <u>September</u> <u>22 Letter to Governors on Inmate Calling Rates</u>, again noting the impact of the pandemic exacerbates the impact of non-cost based inmate calling rates.

#### 5G Fund

In June, NARUC filed *comments*, based on a February 2020 *Resolution*, on an FCC proposal to auction \$9 billion to support wireless 5G services. NARUC endorsed the collection of updated data before the first Phase I auction to properly target unserved areas and suggested the auction could occur prior to 2023. At its October agenda meeting, the FCC released an order that required the collection of updated data – *as NARUC suggested* – but still delayed the first auction to 2023.

#### Water Lifeline

NARUC passed a July 2020 *resolution* that sought federal support for low-income water customers. On October 2, Congress passed the <u>HEROES Act, 2.0</u>. The bill included funding for low-income water customers, but unfortunately any carrier that takes funding is subject to the indefinite disconnection moratoria NARUC has opposed. Although seen widely as a messaging bill, there is a reasonable chance that this idea – and the linkage to disconnection moratoria - could be included in legislation that could pass in 2021.

#### Nuclear Waste Disposal Advocacy

Legislation was introduced related to NARUC's objectives in 2020. The most likely near-term solution involves interim storage facilities proposed by *Holtec* in New Mexico and by *Interim Storage Partners* in Texas. Despite opposition at the Nuclear Regulatory Commission from Texas and New Mexico and the imminent retirement of the strongest proponent of the current law (Rep. Shimkus (R-IL)), we look to South Carolina's Rep. Duncan (R) as the new leader in the next Congress on the nuclear waste fight.

#### Other Activity in Energy Policy

#### **Congressional Preemption of State Jurisdiction**

NARUC helped defeat efforts to include language preempting state jurisdiction on utility disconnect moratorium in the various COVID-19 economic stimulus packages. We also were able to keep a number of preemptive provisions out of the House and Senate energy bills. These issues could return should Congress take up additional stimulus legislation in its "lame duck" session or in the 117<sup>th</sup> Congress.



#### **Authorization of PHMSA Funding**

Successfully lobbied Senate members to include increased funding for state pipeline safety programs. Our efforts resulted in authorization of appropriation language in the Senate bill (S.2299) that passed in August which provided: \$70 million in 2020; \$74 million in 2021; \$78 million in 2022; and \$82 million in 2023. As of October 2020, House and Senate staff were negotiating to get a bill to the President.



#### Communications

Throughout the year, the Communications & Public Affairs Department informed and provided resources to members, policymakers, and others through articles, the website, and social media platforms. No other time has this been more critical for our Association than in the midst of a pandemic, which challenged our ability to hold conventional meetings and conversations. However, we were able to keep audiences connected and delivered relevant and timely content.

We promote meetings and events through e-blasts and social media and branding. Press releases inform the press and others of papers, official statements, and commission news. We had 4,273 media hits this past year, which represents an increase of 190 mentions in the press or 9.4 percent. NARUC was called on for background and on-the-record comments by The Washington Post, The Wall Street Journal, The New York Times and trade press outlets such as E&E News, Utility Dive, and Communications Daily.



#### **COVID-19 Resources**

The novel coronavirus (COVID-19) pandemic presented NARUC with a unique set of circumstances, as well as opportunities to inform the regulatory community. We worked collaboratively with our research arm, the National Regulatory Research Institute, to develop a microsite with COVID-19 news and resources, including a <a href="state-response-tracker">state-response-tracker</a> and map of disconnection moratoria.

#### Meetings, Webinars & Campaigns

The logo for the 2020 theme, *Bridging the Divide*, was designed in-house. Our pivot to virtual meetings required new graphics to convey both interactivity and relevant content. We also maintained all public awareness campaigns throughout the pandemic.

#### Pivoting to Virtual Events

#### Center for Partnerships & Innovation

NARUC's Center for Partnerships & Innovation has stood up to its name in the face of the COVID-19 pandemic. The team quickly pivoted from near-constant in person trainings, workshops, and site visits to dozens of webinars, peer sharing calls, and virtual trainings. In May, we hosted a Virtual Meeting Experiences peer exchange webinar to support member commissions with their own transitions to a virtual environment. We launched an extensively populated and redesigned CPI microsite on the NARUC website, growing content from three pages to more than 35 substantive pages with improved navigation. CPI launched two series of online learning modules for on-demand training: 12 smart grid interoperability modules (5-17 min. each) and 13 distribution systems and planning videos (33–90 min.). The four virtual state working groups launched in late 2019 seemed particularly prescient and didn't miss a beat in offering members opportunities to engage with experts and one another around key topics: electric vehicles, microgrids, performance-based regulation, and grid-interactive efficient buildings. #### **Microgrids State Working Group**

NARUC collaborated with the Department of Energy and NASEO to launch a new microgrids state working group to explore state needs for resilient microgrids, barriers to broader deployment, and strategies to increase microgrid adoption. The working group met for an in-person roundtable on February 13, 2020, to lay the groundwork for members; hosted four webinars; and organized a virtual site visit with Schneider Electric's Global R&D Facility alongside the NARUC Summer Policy Summit in July 2020. The state working group has 59 members from 24 states.

#### MegaModel Utility Business Model Game



On February 13, 2020, NARUC CPI staff facilitated the MegaModel utility business model game for 45 members of NARUC's Performance-Based Regulation State Working Group and federal guests. Players formed teams and simulated managing a utility under different business and regulatory models. Teams played through 10 years of the simulation, selecting generation, transmission, distribution, and flexibility resources while responding to policies and consequential events such as carbon pricing, heat waves, and natural gas price spikes. CPI staff also delivered the training virtually for the first time over WebEx in October 2020.

#### **Cybersecurity Training for State Regulatory Commissions**

NARUC held a virtual cybersecurity training event on September 21-23, 2020, for 164 participants. In addition to commissioners and commission staff from 46 states, staff from NASEO, NCSL, and NGA participated. This training focused on building technical expertise; specifically, in IT/OT technologies and threat mitigation, federal regulatory requirements, and PUC strategies for ensuring utility cybersecurity preparedness. The significant number of attendees underscores the importance that PUCs place on cybersecurity and the value they perceive from these training events. Participants who attended all three afternoons received a certificate of course completion.



#### Distribution Systems and Planning Training

CPI delivered two iterations of its multi-day training curriculum on distribution systems and planning during 2020. NARUC, NASEO, and LBNL offered a distribution systems and planning training designed for Southeastern energy officials on March 11-12, 2020. This was planned as an in-person event, but suddenly and successfully shifted to virtual due to the COVID-19 pandemic. On October 12-14, 2020, NARUC partnered with DOE, LBNL, NASEO, and the Organization of MISO States (OMS), to deliver a Midwest/MISO Regional Training on Integrated Distribution System Planning. These events have resulted in a new Integrated Distribution Systems Planning Learning Module series posted to NARUC's website. Videos include 101-level sessions on electric distribution systems, utility distribution system planning, and state engagement in distribution planning. More in-depth technical sessions cover topics such as planning for resilience and reliability and emerging distribution planning analyses (for example, scenario modeling, hosting capacity analysis, and locational net benefits).


