The Public Utilities Commission will be filling up to two (2) vacancies at either the Financial Analyst 2 or Financial Analyst 3 level based on the education and experience of the successful candidate(s). The Financial Analyst 2 is Job ID 20978.

A Financial Analyst 3 advises the Commission on complex regulatory accounting and financial issues. The incumbent would be expected to examine and interpret, orally and in writing, complex accounting and financial information relating to public utilities, including financial statements, schedules, and written documents.

Job Duties:

- Examine and interpret, orally and in writing, complex accounting and financial information relating to public utilities, including financial statements, schedules, and written documents.
- Evaluate complex utility filings and other regulatory issues, helping to insure that relevant information is provided to assist the Commission, and prepare written reports.
- Conduct research and participate in and/or monitor work-group, legislative, and regional/national forums on regulatory accounting and energy issues.

Qualifications

Minimum Qualifications:

- Bachelor's degree in Accounting, OR Bachelor's degree in Business, Economics, Finance or closely related field with significant coursework in Accounting.
- At least 1 year of work experience as a Financial Analyst 2 or equivalent, with a regulatory agency, utility or similar organization, in the analysis or preparation of public utility accounting records or financial statements; OR
- At least 2 years of work experience in the analysis or preparation of accounting records or financial statements of companies other than public utilities.
- A graduate degree in Accounting, Business, Economics, Finance, or closely related field OR an accounting certification (such as a CPA) may be substituted for one year of experience.
- Knowledge of Generally Accepted Accounting Principles (GAAP) and basic economic, statistical, and financial principles.
- Strong written and oral communications skills sufficient to explain complex accounting and regulatory concepts and issues clearly and concisely.

Preferred Qualifications:

- Good understanding of the electric, natural gas, telecommunications and/or water industries.
- Good understanding of utility ratemaking and regulatory concepts and practices.
- Solid quantitative skills.
- Ability to conduct research and investigations and to perform complex analyses of regulatory accounting and financial issues and related issues such as utility cost recovery.
- Experience conducting financial audits, evaluations or reviews.
