EPRR Task Force: Subcommittee on COVID-19 Work Plan

A. Objectives

The National Association of Regulatory Utility Commissioners (NARUC) convened the Presidential Task Force on Emergency Preparedness, Recovery, and Resiliency (EPRR Task Force) to consider a range of emergency preparedness, recovery and resiliency topics and related policy issues. Subcommittees of the EPRR Task Force have undertaken work in four key thematic areas:

- 1. Federal funding opportunities to support emergency preparedness, recovery, and resiliency initiatives
- 2. Black Sky event planning and preparedness
- 3. Construction standards for FEMA reference in recovery
- 4. COVID lessons learned and best practices

The Subcommittee on COVID-19, comprised of members of the EPRR Task Force and other relevant stakeholders, will study the public utility sector's COVID-19 pandemic response. The Subcommittee will gather lessons learned from the response of state commissions, state, local, and federal government agencies, and private sector entities to the COVID-19 pandemic and compile best practices in an effort to enhance preparation activities and improve collaborative responses for similar future events.

B. Scope

The Subcommittee on COVID-19 will compile lessons learned from stakeholder responses to the current global health crisis; analyze coordination between inter-governmental agencies and external stakeholders; and develop a list of best practices for responding to future public health crises. The Subcommittee will focus on workforce issues, low-moderate income customer issues, utility¹ responses to the pandemic including impacts on utility financial health, private-public coordination, impacts on emergency response, and other key challenges. The Subcommittee will work to incorporate a wide range of diverse perspectives as it develops its interim and final work products. The Subcommittee will document findings in a written report for inclusion in NARUC's *Emergency Preparedness, Recovery, and Resiliency Manual*.

The regular work of the Subcommittee on COVID-19 will be conducted via conference calls, webinars, email, and NARUC meeting sessions. NARUC staff in conjunction with Subcommittee members will engage in extensive collaboration on drafting of a final report and development of supplemental materials and resources.

C. Tasks to be Performed

Task 1 - Develop work plan and schedule for deliverables.

NARUC staff in conjunction with the members of the Subcommittee on COVID-19, will develop a work plan to guide the development and schedule of deliverables. The work plan will clearly delineate areas of responsibility, contain a process map for how to complete these tasks, and include agreed upon timelines

for completing each task. The Subcommittee chair will report on the work plan to the full EPRR Task Force at the NARUC Annual Meeting held on November 9-12, 2021.

Timeframe: September 2020 - October 2020

- Develop work plan September October 30, 2020
- Subcommittee leadership report on draft work plan at NARUC Annual meeting November 9, 2020

Task 2 – Review and collate relevant published literature.

The Subcommittee will work with NARUC staff to identify, collate, and coalesce a relevant body of knowledge pertaining to governmental and utility services, including energy, water, and communications sector responses to the COVID-19 global health crisis.

Timeframe: September 2020- January 2021

- Review and collate relevant published literature October 2020 January 2021
- Subcommittee leadership report out at NARUC Winter Policy Summit February 7-10, 2021

Task 3 – Collect COVID-19 response experience and insights from Subcommittee members and other key stakeholders.

The Subcommittee will work with NARUC staff to convene virtual focus groups to discuss specific experiences with COVID 19, which will add to and refine the information gleaned from the review of published literature. Each focus group will align in their representation by industry, NARUC-membership, and/or association when possible.

Timeframe:

- Conduct focus group meetings February 2021
- Prepare report on focus group findings March 2021 May 2021
- Subcommittee leadership report on focus groups at NARUC Summer Policy Summit July 2021

Task 4 – Prepare final report on COVID Lessons Learned and Best Practices.

The Subcommittee will work with NARUC staff to develop a written report documenting key lessons learned from COVID-19 and best practices for responding to future major public health crises that may impact the provision of essential utility services including energy, water, and communications.

Timeframe:

- Develop final report May 2021 September 2021
- Subcommittee leadership report out on final report at NARUC Annual Meeting November 2021

Task 5 - Create ongoing educational programming for NARUC members, non-member stakeholders, experts, and policymakers about lessons learned from the response from state commissions to the COVID-19 global health crisis.

The Subcommittee will identify and scope educational engagements for NARUC and other relevant stakeholder audiences to explore the latest developments related to COVID-19 response and their regulatory implications. This effort will be supplemented through webinar recordings of expert panel discussions, distribution of external publications relevant to the overarching objectives of the EPRR Task

Force and Subcommittee on COVID-19, and educational roundtables at NARUC meetings meeting to identify the challenges, recent and ongoing, from the collective response to the COVID-19 crisis.

Timeframe: January 2021 - September 2021
