Honorary Resolution for Commissioner ToNola Brown-Bland

Whereas ToNola Brown-Bland served on the North Carolina Utilities Commission as a Commissioner from 2009 through 2023;

Whereas Commissioner Brown-Bland is a native of Alamance County, North Carolina, and graduated with degrees from the University of North Carolina at Chapel Hill(Phi Beta Kappa) and the Duke University School of Law;

Whereas after law school, Commissioner Brown-Bland clerked for the Honorable Alexander B. Denson, a magistrate judge on the United States District Court for the Eastern District of North Carolina prior to entering private practice with the law firm Hill Evans Jordan & Beatty in Greensboro, where she went on to serve as in-house counsel for AT&T Corp;

Whereas Commissioner Brown-Bland joined the North Carolina Department of the Secretary of State in 2001 as director of the business license information office and the charitable solicitations licensing section. In 2002, she joined the staff of the North Carolina Utilities Commission. From 2005 until 2009, she served as associate general counsel with the City of Greensboro;

Whereas ToNola Brown-Bland was appointed to the North Carolina Utilities Commission by Governor Beverly Eaves Perdue in 2009. She served as President of the Southeastern Association of Regulatory Utility Commissioners (SEARUC) and as a member of the Committee on Energy Resources and the Environment Committee, Committee on Critical Infrastructure, and later the Committee on Gas of the National Association of Regulatory Utility Commissioners (NARUC);

Whereas Commissioner Brown-Bland joined the Board of Directors of the National Regulatory Research Institute (NRRI) in 2015, serving as Chair from 2016 to 2019, and she continued to serve on the NRRI Board until December 2024;

Whereas Commissioner Brown-Bland was named Co-Chair of the NARUC Washington Action Program in 2015, where she served in that key position until the end of 2023;

Whereas Commissioner Brown-Bland was named Treasurer of NARUC in November 2019 by President Brandon Presley and served as Treasurer until November 2023. During this same period, Commissioner Brown-Bland served as an officer of NARUC, served on the NARUC Board of Directors, its Executive Committee, the NARUC Audit Committee, and she served as Chair of the NARUC Investment Committee;

Whereas Commissioner Brown-Bland served on the Executive Committee of the National Council for Electricity Planning, including serving as President in 2022-2023;

Whereas Commissioner Brown-Bland has been a tireless supporter of NARUC often accepting the call into leadership positions at difficult times, such as becoming NARUC Treasurer at a time when NARUC was undergoing a major transition of its finance operations just as the COVID-19 pandemic hit;

Whereas Commissioner Brown-Bland has a history of community and civic service, having served on several boards including the Greensboro Bar Association, the Alamance County Historical Museum, and Western Piedmont Residential Services, a non-profit organization that provided residential service to autistic adults, and as a member of the Board of Trustees of her church.

Whereas Commissioner Brown-Bland and her husband Andre have been mainstays at so many NARUC annual meetings;

Whereas Commissioner ToNola Brown-Bland will be remembered by her many friends and colleagues at NARUC, and the numerous organizations in which she has served for her remarkable commitment to public service and her dedication to serving others; *now therefore be it*

Whereas prior to serving as a Senator, Commissioner Clodfelter served as a member of the Charlotte City Council from 1987 to 1993;

Whereas prior to serving as a member of the City Council of Charlotte, Commissioner Clodfelter served as a member of the Charlotte-Mecklenburg Planning Commission;

Whereas Commissioner Clodfelter has served as a trustee of the Z. Smith Reynolds Foundation since 1982;

Whereas Commissioner Clodfelter served as a law clerk for Judge James McMillan of the United States District Court for the Western District of North Carolina;

Whereas Commissioner Clodfelter holds a Juris Doctorate degree from Yale Law School, and a Bachelor's degree from both Davidson College and Oxford University;

Whereas Commissioner Clodfelter was named a Rhodes Scholar in 1972;

Whereas Commissioner Clodfelter graduated from Thomasville High School, where he was the captain of the debate team;

Whereas Commissioner Clodfelter will be remembered at the Commission, the NC Senate, NARUC, and the various organizations for which he served for his commitment to public service, his attention to detail, and his lifelong pursuit of knowledge; *now, therefore be it*

Whereas Judi's management of office supplies saw a seemingly endless stream of FedEx, UPS, and George Allen office supply delivery people bring boxes and packages to her office and treating "Ms. Ford" with family-like reverence;

Whereas Judi was the official Girl Scout Cookies supplier, filling the office with sweets every year;

Whereas Judi had a great sense of humor and was known for sharing her opinions;

Whereas Judi had an immense dedication to NARUC, often working long hours, especially during NARUC meetings;
